We request you to refer to our communications submitted/presented to your esteemed office in response to your communication for submission of declaration under **The Uttar Pradesh Apartment (Promotion of Construction, Ownership & Maintenance) Act, 2010 and allied rules** making our intent very clear that as our project had been completed much before the enactment of this act/allied rules, therefore the applicability of such act/rules are not binding upon us and various information may not be insisted upon from us.

We would also like to let you know that Residents Welfare Association looking after the maintenance of common areas and facilities in the above said complex was registered vide Registration No. 984/2009-10 with the Registrar of Firms and Society during the Year 2009-10 much before the enactment of said act/rules.

You will appreciate the fact that various statements/documents under the said act/rules are to be prepared from the commencement of the project and as our project was completed much before its applicability therefore, it will be very difficult for us to supplement various information to your esteemed office for 2 major reasons, one being the completion of project long ago and secondly the submission of information may not be summarized in the desired fashion.


However, looking in to the punitive action in this matter for non-submission of declaration and to prove our law abiding commitment, we have already

submitted the declaration vide letter dated 09-07-2014 with your office and we are again hereby submitting the declaration Under Protest reserving our right of reiteration that the said act/rules are not applicable upon us in respect of the above said project.

The Declarant hereby solemnly states the following :-

FIRST: The Promoter owns the land which is fully described and detailed in Annexure 'A' to this declaration.

The promoter shall be responsible for full quality control of materials and workmanship at site. The specifications of construction detailed in 'Schedule-A' hereto.

EIGHTH: That for the purpose of stamp duty and registration fees payable on the deed of apartments under S. 13 of the Act, the value of the

(a) land of each apartment would be computed on the basis of the percentage of the undivided share so that the aggregate of the land component of all of the apartments of the building is equivalent to the total value of the land of the building;

(b) the construction of each apartment would be also computed on the basis of the percentage of the undivided share as it bears to the total covered area.

NINTH: that the 'common areas and facilities' as well as the 'limited common areas and facilities' shall remain undivided and no apartment owner shall bring any action for their partition or division thereof.

TENTH: that the percentage of the undivided interest in the "common areas and facilities" as well as the "limited common areas and facilities" established herein shall not be changed except with the unanimous consent of all the apartment owners and approval of Competent Authority expressed in amendment to this deed.

ELEVENTH: that the undivided interest in the 'common areas and facilities' as well as the 'limited common areas and facilities' shall not be separated from the apartment to which they pertain and shall be deemed conveyed or encumbered with the unit even though such interest is not expressly mentioned or described in the conveyance or other instrument;

TWELTH: that neither the dedication of the property to the plan of apartment ownership herein shall not be revoked, nor the property removed from plan of apartment ownership, or any of the provisions herein amended unless all the apartment owners and the mortgagees of all the mortgages covering the units unanimously agree to such revocation, or amendment or removal of the property from the plan by only registered instruments;

THIRTEENTH: that if the property, subject to the plan of Apartment Ownership is totally or substantially damaged or destroyed, the repair, reconstruction, or disposition of the property shall be as provided by the Act;

FOURTEENTH: that where an apartment is sold pursuant to the recovery of the mortgage money, then neither the mortgagee nor the purchaser who derives title to be apartment at such sale or his successors or assigns shall be liable for assessments by the association which became due prior to the acquisition of the title by such acquirer but the association of apartment owners would be entitled to recover the amount subsequent to the date of acquisition of title by such acquirer.

FIFTEENTH: that the 'independent areas', declared herein in the Annexure 'F' are not included as common areas for the joint use of the apartment and the promoter would be at liberty to sell them or to construct thereupon without interference of other apartment owners in view of the provisions of S. 3(p) of the Act.

SIXTEENTH: The promoter shall maintain the common areas and facilities till the association is formed and shall be entitled to collect the maintenance charges @ N.A. per month from the owners of each apartment. [Clause not applicable as the Complex is already maintained by RWA of Aditya Mega City w.e.f. 01.07.2012]


